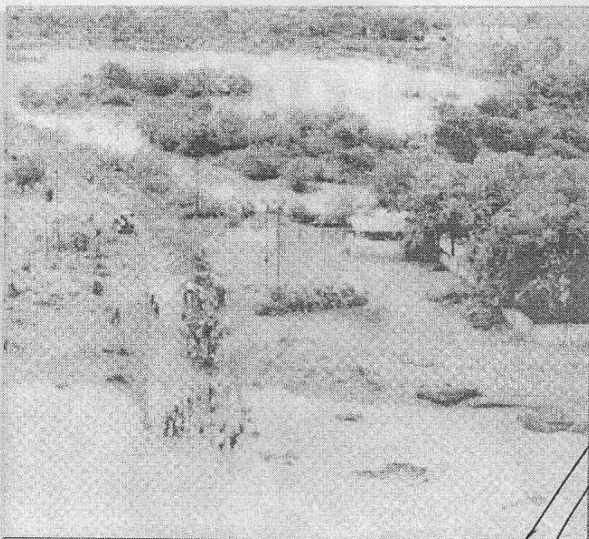

महाराष्ट्र में शिफ्ट गए 3.8 लाख लोग

महाराष्ट्र में बाढ़ प्रभावित इलाकों से अब तक 3.8 लाख लोगों को दूसरी जगह शिफ्ट किया गया है। कोल्हापुर, पुणे, सोलापुर, सतारा और सांगली जिलों में स्थिति ज्यादा चिंताजनक है। सबसे खराब स्थिति केरल की है, जहां 1.5 लाख लोगों को आपातकालीन राहत कैंपों में शिफ्ट किया गया है।

से उन्होंने 3,000 करोड़ रुपये की राशि की मांग की है। यदियुरप्पा ने कहा, एनडीआरएफ की 20 टीमों, सेना की 10 टीमों, नौसेना की 5 टीमों और राज्य आपदा प्रबंधन की दो टीमों बचाव एवं राहत कार्यों में जुटी हैं।

महाराष्ट्र और गुजरात में भी स्थिति चिंताजनक है। महाराष्ट्र में बाढ़ के चलते 27 और गुजरात में

22 लोगों के मारे जाने की खबर है। बाढ़ के चलते महाराष्ट्र के कई अहम मार्गों को बंद करना पड़ा है। यही नहीं गुजरात में तो आंधी के चलते अहमदाबाद और नाडियाड में 8 लोगों की मौत हो गई। हालांकि महाराष्ट्र के सांगली और कोल्हापुर जिलों में बाढ़ की स्थिति में शनिवार को कुछ सुधार होता दिखा।

नायब तहसीलदार प्रतिज्ञा सोनी अपने कार्यालय में राजकीय कार्य का संपादन कर रही थी, उस दौरान कुछ वकीलों ने उनके इजलास में आकर उनसे अशोभनीय एवं अपमानजनक व्यवहार किया। वकीलों द्वारा एक महिला अधिकारी को अपमानजनक शब्द कहे गए। लंबे समय तक उनके कार्यालय में उनको कार्य न करने देने के लिए शोर-शराबा किया गया एवं उनको धमकियां दी गईं। वकीलों द्वारा लंबे समय तक योजनाबद्ध ढंग से नायब तहसीलदार को घेर कर रखा गया, अपशब्दों व गाली-गलौज का प्रयोग किया गया तथा उन्हें कठोर प्रतिक्रिया के लिए बाध्य किया गया। वकीलों द्वारा लगातार पांच घंटे तक राजकार्य को बाधित किया गया तथा पुलिस की मौजूदगी में भी वकीलों द्वारा अपना ये

अशोभनीय एवं अपमानजनक व्यवहार जारी रख गया। राजस्व प्रशासन के इकबाल को बुलंद रखने के लिए इस तरह का दुष्कृत्य करने वाले दोषियों के विरुद्ध कड़ी कार्रवाई होनी चाहिए। अधिकारियों-कर्मचारियों ने कहा कि यदि तीन दिन में दोषियों को गिरफ्तार नहीं किया गया तो उन्हें आंदोलनात्मक कदम उठाने के लिए बाध्य होना पड़ेगा। अतिरिक्त जिला कलक्टर रामरतन सौकरिया के नेतृत्व में जापान देने वालों में चूरु एसडीएम प्लेता कोचर, सुजानगढ़ एसडीएम रतन कुमार स्वामी, रतनगढ़ एसडीएम अर्पिता सोनी, बीदासर एसडीएम शंभुराम वर्मा, राजगढ़ एसडीएम हिममत सिंह, रतनगढ़ तहसीलदार सरिता चौधरी, सुजानगढ़ तहसीलदार अमर सिंह सहित राजस्व अधिकारी कर्मचारीगण मौजूद थे।
